

Madam Woo Hawker High Roller Promotion Terms & Conditions

1. The promoter is: Mayfare Group Ltd (Trading as Madam Woo] whose registered office is at Level 1 – 13 Camp Street, Te Ahi Building, Queenstown.
2. Employees of Madam Woo or anyone else connected in any way with the competition, or helping to set up the competition, shall not be permitted to enter the competition.
 - 2a. The Promotion is open to New Zealand Residents only. Disqualified Participants may not enter in the Promotion.
3. Entry details to the ‘Hawker High Roller Promotion’ are as follows:
 - 3a. Sign up to the Madam Woo Loyalty Programme between 1 February 2017 and 28 February 2017 to be in the draw to be crowned a Hawker High Roller and win a year’s supply of Madam Woo Hawker Rolls.

4. The prize (A year’s supply for Hawker Rolls) is limited to the Hawker Rolls permanently listed on the Madam Woo Menu – Pulled Pork, Percik Chicken, Eggplant.

13a.
